D. <u>Approval of Grant Matches for Volunteer Fire Departments</u>

Robert Boyce received notice that four grants that he applied for on behalf of the VFD's have been awarded. The grants are 50/50 match. Newland and Providence should be able to absorb their match portion within their budget. Weeksville and Nixonton will need a budget amendment in order to proceed. The Finance Committee has recommended approval of transferring \$10,000 out of Contingency and increasing the Grant Match line item in Weeksville VFD and Nixonton VFD by \$5,000 each.

E. Approval of Requests for Occupancy Funds

The Finance Committee has recommended funding for the Highway 17 Association from the Occupancy Tax Fund in the amount of \$1,000 and for US Coast Guard Day in the amount of \$2,500. Applications will need to be submitted to the Tourism Development Authority to allocate the funds from the County's account.

F. Approval of Lease Extension with Dr. Neil Denunzio

The Finance Committee has recommended extending the lease of Dr. Neil Denunzio for the property located at 333 Winfall Boulevard on a month to month basis, not to exceed February 28, 2021, under the same terms and conditions as the current lease. Attached is a copy of a resolution approving the lease extension.

G. Approval of Senior Center Interlocal Agreement

At the March 4th Joint City-County Meeting, the Board approved moving forward with the purchase of the Daily Advance building as a Senior Center and drafting an Interlocal Agreement. The City Council approved the attached Senior Center Interlocal Agreement on March 11th. The agreement has been reviewed by Mike Cox and I, and we recommend approval.
