D. <u>Approval to Retire Duty Weapon and Bade for Retiring Sheriff's Office Employee</u>
The Finance Committee has recommended approval to retire the badge and duty weapon and award them to Corporal David Matthew Meiggs, who is retiring from the Sheriff's Office.

The Sheriff's Office has a policy in place that allows sworn law enforcement officers to receive their badges at no cost and to receive their service side arms, at the discretion of the Board of Commissioners, based on the following price schedule:

Retiring member with 5-10 years of service	\$75.00
Retiring member with 10-20 years of service	\$50.00
Retiring member with more than 20 years of service	\$ 0.00

Corporal Meiggs began working full-time in 1992 and is retiring after 29 years of service with the Pasquotank County Sheriff's Office. The policy requires that the officer obtain a gun permit, or without one, the weapon will be rendered incapable of being fired.
