  - A. Public Hearing on Proposed 2018-19 County Budget
    The Board will hold a public hearing on the proposed 2018-19 county budget that was presented at the last meeting.

Following the public hearing, the Board may approve the budget. Attached is a copy of the Budget Ordinance that the Board will need to adopt when approving the budget.

B. Public Hearing on Water and Sewer System Development Fee Analysis
Local Governments and public authorities that own or operate water and sewer
systems must implement the new "system development fee" schedule by July 1,
2018, in order to begin charging (or continue charging) certain upfront fees for
new development. American Engineering prepared the attached analysis of the
Pasquotank County Water and Sewer Development Fees. No fees were
increased as a result of the analysis. The analysis was published on the County
website for 45 days for comments and as of this time, no comments have been
received.

The fee revenues are restricted to specific purposes, and they must be "accounted for by means of a capital reserve fund". Attached is a copy of a resolution the Board will need to adopt which will create a Capital Reserve Fund for the purpose of funding capital projects related to the County's water and wastewater system.

## 6. Old Business:

A. Appointments to Boards and Committees

At the last meeting, the Appointments Committee recommended the appointments of Una Green and Debbie Brinson to the Joint Community Advisory Committee, as well as Joseph Gregory to the Planning Board. Copies of their applications were previously provided for your review. The Board can either confirm the appointments or can accept additional nominations.

# B. <u>Adoption of Amended Animal Control Ordinance to Provide for Animal Welfare Provisions</u>

At the last meeting, following a public hearing, the Board voted to approve the amended Animal Control Ordinance. Since a police power ordinance such as this must receive a unanimous affirmative vote at the meeting at which it is first considered, with all members present and voting, the adoption could not be finalized because the vote was not unanimous. The Board can now adopt the ordinance by a simple majority vote if it so chooses. Attached is a copy of the amended ordinance.
